4. Pension or retirement plans
5. Tax statements
6. Credit card line of credit
7. Bank statements lacking currency amounts
8. Paystubs

F. IMPORTANT REMINDERS: Student must read and sign.

1. Students in F-1 status are only permitted by United States law to work under certain limited circumstances. Do not count on obtaining a campus job to offset costs. Any anticipation of obtaining an on-campus job cannot be used as a source of funds.
2. Employment opportunities at North Idaho College are very limited.
3. Accompanying spouses and children with an F-2 visa are prohibited from working under any circumstances while in the US.
4. The student is responsible for all costs. In the event that a sponsor is delinquent with financial support, the student is held responsible. Registration may be blocked and housing contracts, transcripts, diplomas, and I-20s may not be issued for individuals who owe money to North Idaho College.
5. Should your financial situation change, your program changes incurring additional costs, or some other change affects your financial situation, you will be required to complete a new Certificate of Financial Responsibility form and provide updated financial documents in order to continue to the next semester.
6. To get a visa and/or enter the US, the student may need to present all financial documentation to the US Embassy/Consulate when asked when you apply for your visa and upon entry into the US.
