Board of Trustees Regular Meeting | October 23, 2024

Board recognizes the rights of citizens to express critical comments about the Board. However, attacks on individual board members are not acceptable. In addition, the public does not have the right to comment on personnel issues or to disrupt the meeting of the Board. The Board Chair has the discretion to interrupt a speaker in the event the individual's remarks address personnel matters or are disruptive. In the interest of a timely meeting, the Board Chair may end public comment at any time after 30 minutes.

The Board will take comment on agenda items from members of the public who attend in person, and commenters will be limited to two minutes per person with no "giving of time" to others. A sign-in sheet will be provided at the entrance to the meeting room and will be collected by 6:00PM (even if the open session convenes later). No advance requests for public comment will be accepted. Remarks are subject to NIC Policy 2.01.03:

"Each public citizen wishing to address the Board on the agenda shall provide his or her name, and the agenda subject on which they wish to comment. Public comment shall be limited as determined by the Board Chair. The Board of Trustees may listen to such public comments but is not obligated to provide responses. If the matter presented requires additional dialogue or action, the Board of Trustees may direct that the matter be placed on the Board's future agenda for further discussion and review. The decision to allow public participation in the meeting is the sole discretion of the Board Chair."

Message From the Chair

Chair Mike Waggoner reported that NIC enrollment is up over 15%, College finances are healthy and that the Board is improving its operations. He said that he and President Swayne have met with the state legislature concerning funding requests for the POST Academy, Nursing and Health Professions and cybersecurity enhancements. Chair Waggoner expressed his gratitude to the Board, the President, Administration, Faculty, Staff and Students for the great work being done, and said he looks forward to a new and successful year for North Idaho College.

Celebrating Success

President Swayne explained that NIC's Surgical Technology program was recently visited and accredited by an external review council. Dean of Instruction for Nursing and Health Professions Erlene Pickett introduced Terra Lawson-Gilbert, the Assistant Professor/Program Director of Surgical Technology. Ms. Lawson-Gilbert and her team shared a presentation and introduced the program's current students as well as two former students who shared their success stories. Ms. Lawson-Gilbert proudly announced that the College's Surgical Technology program received exceptional reviews from the Commission on Accreditation of Allied Health Education Programs. CONSTITUENT REPORTS

<u>ASNIC</u>

ASNIC President Joseph Moran reported on ASNIC's public September Board meeting, special position elections, recent Fast Grant approvals, senator position vacancies and preparation for the upcoming NWCCU visit. He stated that he and ASNIC Vice President Blake Sanchez will serve as moderators at the NIC Board of Trustees Candidate Forum being held at the Salvation Army Kroc Center on September 26, 2024.

Faculty Assembly

Faculty Assembly Chair Kathleen Miller Green reported on the Faculty Assembly's recent activity. Her report is included as an addendum to these minutes.

Staff Assembly

Staff Assembly Chair Katrina Bjorkman reported on the Staff Assembly's recent activity. Her report is included as an addendum to these minutes.

<u>Senate</u>

Senate Chair Julie Bailey reported on the Senate's recent activity. Her report is included as an addendum to these minutes.

PRESIDENT'S REPORT

President Swayne stated that all required accreditation reports were submitted to and received by the NWCCU on August 30, 2024. He reported that the visiting team continues work on finalizing their schedule for the October 14 - 15, 2024 site visit.

Dr. Swayne said that his report at this meeting will focus on enrollment management, as it impacts nearly every area of the College. He explained how the Enrollment Dashboard tool works and shared current updates, highlighting various increases over last year, most notably 15.6% in overall enrollment, 40% in new students, 65% in male enrollment and 35% in new full time students. The President acknowledged the team responsible for the increases and expressed his sincere appreciation for their commitment.

President Swayne also reported on other topics such as economic development in Sandpoint, NIC's undefeated men's soccer team, the upcoming Rathdrum Rumble, program alignment initiatives at the Workforce Training Center and ongoing progress with strategic planning implementation.

INFORMATION ITEMS

Human Resources

Vice President for Finance and Business Affairs Sarah Garcia gave a presentation on behalf of the Human Resources department. Her report included statistics on employee headcount, employee departures, employee retention/engagement and FY25 initiatives. Ms. Garcia's presentation is included as an addendum to these minutes.

Athletics Follow Up

Athletic Director Shawn Noël gave an Athletics department update to include budget, additional services offered, such as English as a Second Language (ESL), and community involvement activities. Discussion followed. Mr. Noël's presentation is included as an addendum to these minutes.

Dean of Instruction, Transfer and General Education Sherry Simkins shared an overview of Academic Freedom. She answered questions and clarified aspects of the related policy that is making its way through the review process. Her presentation is included as an addendum to these minutes.
















Faculty Assembly Chair Report to the NIC Board of Trustees

Chair Waggoner, Trustees, President Swayne and this fantastic NIC Community, both on campus and off! As of today, only three more shopping months until Christmas!

On September 12th, we held the second Faculty Assembly meeting of the academic year. We began by welcoming new faculty members to the assembly, heard information during Faculty Celebrations about the upcoming trip that Carletta Brenneman, adjunct professor of Modern Languages is offering to Germany and Switzerland.

Then we heard regular reports from Senate, Student Learning Outcomes Assessment committee, Advising Update, Open Education Resource Committee, and an Adjunct Faculty Report. We then moved on in the agenda to address the following:

Chair Report

I reported to the Faculty about the 1) President's Planning Retreat; 2) the working session with Collaborative Brain Trust, our Strategic Planning consultants to draft the objectives for each of the approved goals in our developing Strategic Plan; 3) informed the faculty about the open forum scheduled during the upcoming NWCCU site visit and discussed ways to prepare – including reviewing the same set of questions given to the Trustees during their August ACCT training as well as becoming familiar with the Special Report submitted to the NWCCU in August; and 4) announced that the NIC Foundation Grant applications are now available and must sent be to the appropriate Vice President or Provost for signature by October 11th.

Business:

Election of Senate Alternate – as the College Senate was still in need of one Faculty alternate, I opened nominations. Cindy Dicken, Assistant Professor of Music was nominated and voted in by unanimous acclaim. She will begin attending Senate meetings this month.

We reviewed with the Faculty the updated calendar for submissions to Curriculum Council for new or revised courses. The new calendar schedule will streamline the curriculum development process, enhance academic planning and ensure timely implementation of approved curriculum changes.

We ended the meeting with an announcement for the Good of the Order about this year's **Constitution Day** event, an educational program requirement by the US Department of Education for all institutions receiving federal funding. It was an event sponsored by Kyle Serrott, our very own Assistant Professor of Native American Studies and was held September 19, 2024, from 1:00-2:30pm in the Lake CDA room of the SUB. This year's event focused on the role of tribal constitutions in our society. Vice Chairman of the Kootenai Tribe of Idaho, Gary

Aitken Jr. presented on the Kootenai Tribe of Idaho's 50th anniversary of the Tribe's Declaration of War on the United States, which occurred on September 20th, 1974. This was a "peaceful" war as a part of the struggle for tribal sovereignty, self-determination, and land rights. The event was open to the NIC community and regional communities as well, a Zoom link was be available for those who wish to join virtually, and a recording of the session was made for future use in classes and events. About 50 people attended and it was a wonderful celebration of Constitution Day, which is a required by the US Department of Education for all institutions receiving federal funding.


Senate Report



Academic Freedom

- 2.B.1 Within the context of its mission and values, the institution adheres to the principles of academic freedom and independence that protect its constituencies from inappropriate internal and external influences, pressures, and harassment.
- 2.B.2 Within the context of its mission and values, the institution defines and actively promotes an environment that supports independent thought in the pursuit and dissemination of knowledge. It affirms the freedom of faculty, staff, administrators, and students to share their scholarship and reasoned conclusions with others. While the institution and individuals within the institution may hold to a particular personal, social, or religious philosophy, its constituencies are intellectually free to test and examine all knowledge and theories, thought, reason, and perspectives of truth. Individuals within the institution allow others the freedom to do the same.







Campus Speech Activities--Time, Place, and Manner

This policy and subsequent procedures informs members of NIC and the public of the time, place, and manner in which they may engage in constitutionally protected speech and expression at North Idaho College. It is intended to ensure the primary educational purpose of the college which includes promoting the free exchange of ideas and the dialogue which it creates.

According to FIRE (The Foundation for Individual Rights and Expression):

The First Amendment protects your right to speak your mind with only limited exceptions. But public colleges are allowed to maintain reasonable time, place, and manner restrictions on student speech in public areas of campus. These regulations must be viewpoint, and content-neutral rules on where, when, and how you can demonstrate on campus, in order to prevent disrupting the educational environment. Even in open, outdoor areas where campus protests are common, colleges might restrict some or all use of amplified sound, setting up tables or other structures, camping, and overnight protests. To be constitutional, those rules must apply to everyone, no matter their viewpoint and even when they're not trying to convey a message at all.
